2. Osceola County Pretrial Release is entirely publicly funded. Our operating and budget for the year 2017 was \$627,450.76.
3. There are NO funds allocated to assisting defendants obtain non-publicly funded release.
4. Most of Osceola County PTR defendants pay \$10 per month for the use of the tele-reporting system. Those individuals ordered to Electronic Monitoring pay \$5.18 per day for rental of the GPS equipment. Drug tests are \$20.00 and alcohol tests are \$13.20. This money is not revenue. It is paid to the vendor who provides these services.
5. Osceola County PTR currently employees eight (10) individuals; one (1) Community Supervision Supervisor, one (1) Community Supervision Assistant Supervisor, and (8) Community Supervision Officers.
6. Osceola County Pretrial Release staff interviewed [4296](#) inmates and assessed [5081](#) inmates during the calendar year of 2015.
7. Pretrial Release staff made eight (2813) recommendations for Pretrial Release in 2017.
8. Osceola County Pretrial Release DOES NOT use indigence as a determining factor for release.
9. The following defendants were granted non-secured release who either failed to appear (**FTA**) for a scheduled court date (all FTAs result in a warrant) or were arrested for another offense (**RRA**) while on the Pretrial Release Program in the calendar year 2017:
