2. Our operating and budget for the fiscal year 2017-2018 was **\$727,686.89**.

3. a. Our total budget is included within Osceola County Corrections Dept.
Osceola County Pretrial Release is entirely publicly funded

b. There are NO funds allocated to assisting defendants obtain non-publicly funded release.

c. Most of Osceola County PTR defendants pay \$10 per month for the use of the tele-reporting system. Those individuals ordered to Electronic Monitoring pay **\$5.35** per day for rental of the GPS equipment. Drug tests are **\$20.00** and alcohol tests are **\$13.20**. This money is not revenue. It is paid to the vendor who provides these services.

4. Osceola County PTR currently employees eight **(10)** individuals; one **(1)** Community Supervision Supervisor, **(1)** Assistant Supervisor and **(8)** Community Supervision Officers

5. Osceola County Pretrial Release staff interviewed **4669** inmates. Osceola County assessed **5170** inmates. The calendar year of 2018.
At the time of assessment it is not determined by the court if the defendants are indigent. Every inmate assessed a risk assessment was completed.

6. Pretrial Release staff made eight **(2889)** recommendations for Pretrial Release in 2018.

7. The total number of defendants recommended against non-secure release **(1088)**. This total began begin tracked in July 2018 (bond w/ptr)

8. The total number of defendants who were release after a Pretrial release recommendation was made. **(808)**

9. Total number of Defendants assessed and interviewed who were declared indigent by the court **(2556) Indigent upon release to PTR**

10. The total number of defendants who were accepted in The Pretrial release program as a condition of their bond (1447)
