1. The Osceola County Pretrial Release Program (PTR) is located at 402 Simpson Road, Kissimmee, Florida, 34744. The operating budget for FY 2019/2020 was \$581,582.40 and is entirely publicly funded through the Osceola County Corrections Department's annual budget.

2. The operating and capital budget for FY 2019/2020 was \$581,582.40 and is entirely publicly funded through the Osceola County Corrections Departments annual budget.

3(a). The PTR Program is entirely publicly funded.

3(b). There are zero funds allocated to assisting defendants obtain release through a non-publicly funded program.

3(c). A majority of program participants pay \$10 per month for the use of the telephonic reporting system. Defendants court-ordered on electronic monitoring pay \$5.35 per day for the rental of the GPS equipment. Drug tests are \$20.00 and alcohol tests are \$13.20. These fees are not utilized as a revenue source and are paid to the vendor that provides these services. Additionally, arrangements are made for indigent defendants and no defendant will be violated for failure to pay fees.

4. The PTR Program currently has eleven (11) employees; one (1) Supervisor, one (1) Assistant Supervisor, and nine (9) Community Supervision Officers.

5. PTR staff assessed 4,518 inmates and interviewed 4,209 inmates for pretrial release.

6. PTR staff recommended 858 inmates for non-secured release.

7. PTR staff recommended 858 inmates for non-secured release.

8. 478 defendants were granted non-secured release due to PTR staff recommendation.

9. 1,209 defendants were declared indigent by the court.

10. 722 defendants were accepted into the pretrial release program with a surety or cash bond.

11. Risk assessment tools were used in determining non-secured pretrial release recommendations for 4,209 defendants. 285 inmates refused to provide the necessary information to complete the risk assessment.

12. Appendix A provides for the minimum requested information required by statute.

13. 595 defendants were accepted into the pretrial release program with no prior criminal conviction.

14. Appendix B provides the name and case number of each person granted non-secured release who; failed to attend a scheduled court appearance, was issued a warrant for failing to appear, or was arrested for any offense while on release through the pretrial release program.

15. Any additional information deemed necessary:

For calendar year 2020, the Osceola County PTR Program maintained a 88.2% safety rate and a 95.5% court appearance rate.
