If you choose to represent yourself, you may want to research the Florida Statutes and Florida Rules of Civil Procedure which govern sealing or expungement of criminal records.

You must receive a "Certificate of Eligibility" from FDLE prior to completing this packet. For more information please visit: www.fdle.state.fl.us

Note: The certificate is valid for one year from the date listed.

Complete the following forms, make a copy for your records, and then file the originals with the Osceola County Clerk of the Circuit Court with the appropriate filing fee:

- ❖ Affidavit; and
- ❖ Proposed Order to Expunge Under Section 943.0585, Florida Statutes, and Florida Rules of Criminal Procedure 3.692

Once payment is received, the certified copy of the signed Order to Expunge or Seal will be disseminated to you and any government agency that possesses your record. There is a \$42.00 service charge plus the costs for the certified copies.
